

# **Strategy 2022-2026**

# Wool Classers & Classing

- 14,573+ registered classers, down 1,669 (-10.3%) compared to 2019-21,
- Classer Category Movement:
  - AWs (-723): NSW (-401),
  - OCs (-818): SA (-304),
- Fact: AWEX registers 6 new AW classers for every 1 new OC classer. This is a trend that has continued over the last decade.
- Issues of concern:
  - Cost of and access to classer training as follows: see new TAFE initiatives in NSW and TAS,
  - Ongoing access to a skilled and experienced workforce, and
  - Employment conditions in the wool shed.
- WoolClip uptake has been strong with existing classers; however, the level of training in WoolClip of new and current students needs to lift to meet the increasing demand from industry. AWEX will be working with trainers over the coming months to increase their confidence in using WoolClip and to ensure new wool classers are job ready.
- The 2023 National Graduate Wool Classer Competition will be held at the Sydney Royal Easter Show on Tuesday 11th April.

# CERT IV Wool Classer Training: NSW & TAS

Industry has been calling for opportunities and programs to incentivise training in skills urgently required in the wool industry.

In December, TAFE NSW and TAS announced that 2023 would be Fee-free for CERT IV Wool Classing.

With the announcement of Fee-free courses in 2023, TAFE NSW & TAS have answered that call to provide the requisite training.

Please follow the links below to learn more about the courses and eligibility. Please share this with your staff and clients.

Note: at this time only NSW & TAS are offering Fee-free courses.

#### Commonly asked questions:

How long is the course?

The enrolment period is 2 years for CERT IV; however, most trainers will provide resources and course material which would allow for study at your own pace, which could shorten the course length.

Is there still an Owner Classer course?

Yes, this is CERT III in Wool Clip Preparation. The CERT III comprises 11 units that are common to the CERT IV course. Both courses comprise 14 units of competency.

What do the Fee-free Wool Classer TAFE course involve?

NSW and Tasmania have joint initiatives with Government to provide Fee-free courses that include wool classing CERT IV (AHC41316).

To be eligible for Fee-free TAFE NSW, at the time of enrolment the individual must:

- · Live or work in New South Wales.
- Be an Australian or New Zealand citizen, permanent Australian resident or a humanitarian visa holder.
- Be aged 15 years or over, and not enrolled at any school.

Fee-free TAS TAFE and vocational education is a joint initiative of the Australian and Tasmanian Governments, providing tuition-free training places to students wanting to train, retrain or upskill.

# **WoolClip – Momentum is Growing**

- WoolClip has recorded its biggest 12 month period yet, breaking through 100,000 bales for the first time in a calendar year.
- In calendar year 2022, 113,636 bales were captured and processed using WoolClip.
   This eclipses 2021 by +45.1%.
- The first half of season 22/23 has produced 64,750 bales and increase of +67.4% for the same period in the previous season. These spectacular results are largely due to:
  - Acceptance and increasing use of technology in the wool shed,
  - Greater awareness and understanding of the value and importance of traceability,
  - Improved accuracy and efficient transfer of wool data (including the NWD), and
  - AWEX's increased presence and commitment to WoolClip training and extension across Australia.

AWEX is offering training to all AWEX members and is present at key industry events including Ewe Competitions, Field/Technology days, broker training/client days and classer forums.



# eBale & Traceability Project

AWEX received commitment from all major member, grower and industry organisations to implement eBale. The announcement, made on 14th Nov 2022, https://www.awex.com.au/members/members-update/, highlighted the following key dates:

- 31 December 2022 current bale label production will cease
- 1 January 2023 production of the eBale label to commence
- 30 June 2023 last date for importation of current non-RFID packs
- 1 July 2023 only eBale packs to be imported from this date

The media release has been well received both in Australia and overseas. The first milestone date (31st December 2022) has passed with only eBale labels now available for purchase for pack manufacturing.

The next critical date will be 1st July 2023. From 1 July, only eBale packs, complete with RFID/QR Code labels, will be able to be imported into Australia. This will fast track the adoption of eBale and improve Australia's wool credentials. It is anticipated that the first batch of eBale packs, complete with RFID/QR Code labels, will be available for purchase in late February.

AWEX appreciates the support received from a broad cross section of the wool industry for this project and we look forward to the implementation of eBale and the industry leveraging the technology. AWEX has committed to purchasing 5 million RFIDs which is equivalent to 2-3 years of wool packs.

#### **Retro-fitting Non-eBale packs**

AWEX has available (in stock) ~20,000 RFID/QR Code tags for purchase. These adhesive tags can be used to 'retro-fit' existing non-eBale packs. Tags are applied to the bale label for use on farm or in a warehouse.

eBale Tags are available for purchase at a cost of \$0.80ea + GST, including postage. To purchase eBale Tags please contact AWEX.

#### **Warehouse Integration**

As part of this project, AWEX has engaged technical expertise to work with brokers and warehouses. This involves integrating the data into their business with basic functionality including: receiving a bale, finding a bale, stocktaking and dispatching a bale.

#### eBale

eBale is the application of a unique bale-ID (number) via a RFID/QR Code on each individual wool pack (ePack). The QR Code is captured on-farm via WoolClip. WoolClip creates, registers and validates the unique bale-ID for integrity purposes. The bale-ID contains a unique number which can then be matched against the record on WoolClip, including Account, PIC, Farm Brand, NWD, bale details etc.

## 2023 NWD Review

AWEX will commence a comprehensive review of 2023 NWD in the coming weeks.

The review of the NWD will be undertaken in 2023, for implementation in July 2024. The length of the review period is designed to ensure there is sufficient time for the consideration of all submissions and subsequent consultation with industry, and to facilitate a smooth transition to the next version.

The 2023 Review of the NWD will be undertaken by AWEX through an Industry Consultative Committee (NWD ICC). An Independent Chair will be appointed to the NWD ICC, with Committee members appointed in consultation with industry representative bodies.

The call for submissions was distributed widely on 20th January 2023. Submissions must be received by COB Monday 13th March 2023.



#### The Market


- Certified Integrity Scheme (CIS) indicators are being released as part of the weekly market report.

- The first half of 2022/23 season has seen a considerable increase in volume across auction centres. 2022/23 volume of 824,933 bales is the biggest for the same period in six years.
- Seasonal conditions have been wildly varied over the six year period particularly over the Eastern states.

At the Australian Wool Production Forecasting Committee's December meeting, shorn wool production for 2022/23 remains unchanged at 340 Mkg greasy, up 5.0% on the 324 Mkg greasy estimate for 2021/22.

Since then, QLD and NSW have experienced more heavy and flooding rains.
