AWEX Code of Practice Review & Online Survey

AWEX has launched the triennial review of the 2013-15 Code of Practice (*Preparation of Australian Wool Clips: The Woolclasser*). The Code of Practice is the bench mark standard for the preparation of Australian wool reflecting the expectations of buyers and providing valuable guidance to woolclassers, wool growers and industry stakeholders.

The review will be extensive and is open to all woolclassers, wool growers and industry stakeholders to ensure full consideration of all issues and endorsement of the content of the Code of Practice.

Woolclassing is the first step in the wool processing pipeline and how wool is prepared determines its potential future use and competition for each clip.

The completion of the review will coincide with the launch of the 2016-18 Woolclasser Registration.

AWEX invites you and/or your organisation to provide input to this review. The review period is now open and will close on <u>28th November</u>, <u>2014</u>.

Input can be provided in two ways:

1. Writing:

Written submissions may raise issues from the 2013-15 Code of Practice or new industry issues that you would like considered.

Submissions must include the topic and a brief description of why this matter should be considered. Suggestions on how each issue might be addressed are also welcome.

All submissions must include the name and address of the author and be received by AWEX by the 28th November 2014 to be considered.

All submissions will be treated in confidence.
