# N46/15/5.0 DELIVERY AREA DEFINITIONS/TERMINOLOGY

The Secretary tabled the terminology and/or definitions used by brokers when describing the Delivery Area(s) included as part of the Post Sale Charge (PSC). The terminology varied from very specific (e.g. road boundaries) to very general (e.g. Melbourne). Some were out of date and some were missing.

#### NASC concluded:

- Delivery Areas and/or destinations included in the PSC must be clearly defined in the Broker Terms of Sale and Buyer Post Sale fee schedule,
- Any Areas referring to AWEX rules should be removed (as AWEX Rules no longer include standard delivery areas),

#### It was AGREED:

1. All brokers be asked to review their Delivery Area definitions for next season.

#### ACTION(S) Seller Representatives to communicate with constituents.

#### N46/15/6.0 ROOM 2 CATALOGUES – SOUTHERN REGION

NASC considered a request to combine both the hardcopy yellow and blue catalogues together in Southern Region.

#### It was AGREED:

- The Room 2 catalogues (Yellow and Blue) in Southern Region were to be combined under a single catalogue cover with the Yellow catalogue contents first.
- 2. The consolidated catalogue would have a Blue Cover.
- 3. There would be <u>no change</u> to existing lotting or showfloor standards. Lots are to be presented in Yellow then Blue sequence as current.
- 4. This convention would commence from Week 6.

#### N46/15/7.0 SALE ROOM DISPLAY
