Thank you for renewing your Woolclasser registration for the 2016-18 triennium.

AWEX has undertaken an extensive review of the Code of Practice to coincide with the re-registration process, with feedback being sought from all industry stakeholders and Woolclassers. Thank you to the Woolclassers (over 900) who completed the on-line survey that was conducted late in 2014. This information, along with submissions received from industry stakeholders, was collated and provided valuable feedback to the Industry Services Advisory Committee (ISAC) review of the Code of Practice.

The results of the survey indicated that; overall, there was a high level of satisfaction with the 2013-15 Code of Practice and its tabbed section format. There was general agreement from Woolclassers and the broader industry for minimal change. The revised 2016-18 Woolclassing Code of Practice is presented in a similar format to the 2013-15 version.

You will notice that your new stencil and stamp do not have an expiry year. Your registration is valid for the triennium to December 2018. In the event of a stencil or stamp being broken, contact AWEX for a replacement.

What's in your re-registration pack?

Stencil

The new orange stencil has your stencil number and registration category on it but no expiry year.

Stamp

The self-inking stamp is a new model, which will overcome some of the problems that were experienced with the previous stamp. It does not have an expiry year.

Bale Label Permanent Marker

The black permanent marker pen is UV resistant and is to be used for the completion of bale labels.





What **HAS** changed in the Code of Practice?

The Woolclasser's Role

Extra information regarding the <u>Classers</u> role in relation to the Preparation of Wool and Quality Management

Definitions

- Revised definition of Classed Wool.
- Updated definition of "R" (Runs With) Shedding Breeds this now includes reference to running with Goats.
- New descriptions for Crossbreds and Composites, with information on how to class their Wool.

Bale Branding Descriptors

• Addition of the AA M branding code descriptor for light pen stain in Merino fleece wool.

Preparation Standards

- Extra detail on the preparation of crossbred lambs and skirtings, highlighting the importance of uniformity of wool quality/ count in classed lines.
- Shedding Breeds is now a tabbed section with additional preparation information included in the Classing Standards for fleece wool.

Bale Pressing

- Effective from 1st January 2016, the minimum bale weight for non-speciality wool will be 120 kg. There is no change to the maximum bale weight, this remains at 204 kg. There is no change to the minimum weight for single bale, speciality Superfine fleece wool lines (ASF4. or better, 18.5 micron and finer), this remains at 90 kg.
- Additional information on the new wool packs, with the emphasis on the correct procedures for the closing and labelling
 of bales and pressing within the 1.25 metre maximum bale length.

Classers Specification/ National Wool Declaration

• The example Woolclasser's Specification and National Wool Declaration (NWD) has been updated - please carefully read the explanation notes. The Classer should always liaise with the Owner/Manager regarding the Dark and Medullated Fibre Risk and Mulesing Status declarations made using the NWD. The Owner/Manager must sign the NWD for it to be valid. Note, all NWDs are eligible to a random audit/inspection as part of the NWD Integrity Program.

What **HAS NOT** changed in the Code of Practice?

AAA M

Responses to the Woolclasser's survey revealed some classers have concerns about managing the use of the multiple
lines described as AAA M in the shearing shed. The effective use of Bin Codes, accurate documentation, visible
labelling of wool bins and clear communication are important in this process.

Skirting of Fleece Wool

• In the Review, some Woolclassers suggested that unskirted fleece wool should be recognised as classed. At this time, skirting is considered an essential component of classing to the COP. Note; however, that the Code recommends skirting as lightly as possible. Fleece wool prepared and classed to the Code of Practice standards must be skirted (except for black, heavy dermo and hard cotts/matts). Unskirted wool must not have the stencil placed on the bales or stencil details on the specification.






Example of Activity Detail Screen
