National Wool Declaration - Update

2018 marks the 10th year since the introduction of the National Wool Declaration (NWD).

Speaking at the AWI 2018 Breech Flystrike R,D&E Technical Update in Sydney yesterday, Dr Kerry Hansford, AWEX Quality and Project Manager, reported on AWEX's analysis, findings and trends since the introduction of the NWD and NWD-Integrity Program (NWD-IP).

The NWD declaration rate has steadily grown over that 10 year period and has become a critical piece of information for Buyers when making their purchasing decisions.

"Over the last 10 years AWEX has regularly reviewed the NWD and its Integrity Program, with each review focusing on those issues that will ensure that the NWD continues to deliver what the world is demanding into the future." Dr Hansford said: "Each review refines the NWD and gives our customers greater trust and confidence in the credentials of Australian wool."

Dr Hansford said that: "Whilst the definition of mulesing has not changed, i.e. the removal of skin from the breech and/or tail of a sheep using mulesing shears, the definition of Ceased Mulesing (CM) changed in 2017 to remove previously identified loopholes or ambiguities, i.e. No lambs born on the property in the last 12 months have been mulesed, and no purchased ewes or wethers are mulesed".

"The number of requests AWEX receives from Buyers for Certificates of Mulesing Status for their customers continues to grow each year. Importantly, when a non-compliant clip is identified, Buyers are now faced with the predicament of cancelling their purchased lot(s)," said Dr Hansford.

Statistically Speaking:

- Between 2008 and 2017, the Australian declaration rate has increased from 38% to 66%.
- And for each Mulesing Status:
 - NM Non Mulesed declarations have increased from 3% to 12%,
 - PR Pain Relief declarations have increased from 3% to 32%.
 - M Mulesed declarations have decreased from 29% to 20%, and
 - ND Not Declared have decreased from 62% to 34%.

Whilst nationally Australia is achieving a declaration rate of 66%, when you drill down further, States such as TAS and VIC are achieving high declaration rates of 82% and 78%, respectively. Conversely, the WA declaration rate is 35% and has great potential to improve.

The Market:

Since the introduction of the NWD, the most often asked question is "what is the market saying?" and "What premium is in the market for declared wool, especially NM"?

Markets are live and can fluctuate for a number of sometimes unrelated reasons. To identify what market signals exist requires market volume.

After 10 years, the volume of wool being sold is consistently providing sound price signals that can be reported.

The market is giving clear indicators on how the declaration of Mulesing Status can influence price.

Non Mulesed (NM) is clearly indicating a market incentive of 40 - 50 c/kg clean for 16 - 20 μm wool. These results are an average, with the variation in price indicating that some of the finer Merino types receive more than 100 c/kg clean for wool with a NM declaration. This is the clearest price signal of all the Mulesing Status categories, with the other categories being modest or non-existent (see Additional Data below).



After ten years, the NWD has clearly established itself as an important component of the Australian wool market. Over the next 10 years, AWEX expects that the reliance on the NWD will continue to grow as Buyers' orders become more highly specified to meet the needs of their customers.

Criteria for the Calculation of Premiums and Discounts for Mulesing Status

- Australian Stored; Merino Fleece/Weaners & Crossbred Fleece, n ~ 38,000 lots for 2017.
- >30 N/ktex, >60% Schlum Dry, <2.2 VMB, Styles 4/5, Good/light colour (incl. H1), P Cert.
- Lengths according to Diameter Range: 70–95 mm (<18 μm), 75–99 mm (19–21 μm), 83–104 mm (22–24 μm), 90–110 mm (26–29 μm), 100–130 mm (30–34 μm).
- Records per group (micron/NWD status) >2, empty cells when not enough data to generate a Premium or Discount.
