Implementation of the NWD V8.0

On 27th March 2020, AWEX circulated the outcomes from its 2019 Review of the NWD, Version 8.0, March 2020. This release sees the development of associated NWD forms, brochures, business rules and the timetable for implementation.

NWD V8.0 Business Rules:

NWD V8.0 Release Notes and Business Rules Issue 5, 7th April 2020

These Business Rules are designed to (a) clarify how the NWD V8.0 is interpreted, and (b) provide programming information to IT providers including translation and combination rules.

Important Dates NWD V8.0 Implementation:

1st July 2020: New Mulesing Status Code(s) accepted through data systems. This requires the following:

- Shearing shed stationary (NWD V8.0 form) updates to be completed by individual brokers.
- IT system changes to be completed.

From this date:

- Declarations of Pain Relief (PR) made on NWD V7.0 or earlier will be converted to mulesed with Analgesic/Anaesthetic (AA).
- Declarations of Ceased Mulesing (CM) made on NWD V7.0 or earlier will be accepted "as is", since the definition of CM has not changed between V7.0 and V8.0, only the formatting differs.

1st July 2021 forward: Only V8.0 (or later) will be accepted. Declarations made on NWD V.7 and all earlier versions are not supported (excluding old or reoffer stock). Where NWD V7.0 or earlier is used, Not Declared (ND) should be recorded in Sale Catalogues and Test Certificates.
