## **Wool Classing**



#### **Wool Classer Registration**

At its recent meeting the AWEX Board accepted the recommendations from the Registration Review Committee (RRC) to:

- suspend the registration of two wool classers for misuse of stencil, and
- to place a wool classer on active watch and corrective action for more than one contamination incident.

Wool Classers are referred to the RRC where a complaint has been received, or where AWEX believes has established a breach of the Rules of Registration or significant/recurring preparation issues falling below the Code of Practice Standard have been recorded.

The RRC will consider two cases at its next meeting.

## Wool Classer Registration Renewals 2025-27

AWEX will invite wool classers to renew their registration for the 2025-2027 period in October 2024. Please keep an eye out for correspondence from AWEX and ensure your contact information is up to date.

## Keep Your Clip Clean Campaign Relaunched



#### **Contamination costs everybody**

The Australian Wool industry has a long and proud history of quality wool clip preparation that is recognised and valued by our customers.

Despite this, clip contamination remains a serious concern. Contamination from items such as twine, bags, cloth, hooks, wire, and tools continue to be an issue that cause havoc in wool processing, either by damaging finetuned specialist equipment, or when processed amongst the wool fibres and contaminating, in some circumstances, an entire batch of woollen product being produced.

In partnership with our global wool processor partners, the Keep Your Clip Clean campaign has been relaunched to raise awareness of the seriousness wool contamination can play in the Australian clip, its impacts, and how we can all help avoid it.

The **Keep Your Clip Clean** poster has been refreshed, raising awareness of contamination using examples found in wool bales from Australia.

With each wool pack now having a unique number, accessed via its QR code or by scanning its RFID tag, eBales are a powerful traceability tool that can start on-farm.

AWEX's WoolClip platform, which digitally captures the Wool Classer's Specification and online NWD declarations, can also capture an eBale's unique ID, by simply scanning the eBale's QR code on-farm in WoolClip.

Doing this in WoolClip is a simple way for growers and Classers to unlock the full potential of eBales including:

- ✓ No duplicate Bale numbers, ever.
- Avoiding delays, share wool clip details with your chosen marketing organisation instantly.
- ✓ Trusted traceability linked to a unique Bale ID:
  - Online wool specifications
  - Online NWD declarations
  - Capture accurate farm information, including PIC
  - Synergies with digital logistics and warehousing
- ✓ Identification of wool bales in the event of an Exotic Animal Disease outbreak.





## **WoolClip Success Continues**

The uptake and acceptance of WoolClip continues to accelerate in 2024.

This growth continues to be supported by Brokers and Private Treaty Merchants, combined with growing interest from growers and Classers wanting to improve data capture on farm, including the use of eBale.

As eBale and ePacks become more visible throughout Australia, it is expected that interest in WoolClip will grow further. AWEX will continue its extension program for WoolClip & eBale in 2024.

- In 2022/23 a total of 159,279 bales were captured using WoolClip.
  - +81.8% increase on 2021/22,
  - ~8.6% of estimated wool production (WPFC),
- In the recent rolling 12-month period (Apr- Mar 2024) 243,279 bales were captured on WoolClip
  - +79% increase on the same period in 2022,
  - ~14% of estimated wool production (WPFC)

## **WoolClip Training & Events**

These popular sessions allow users to gain confidence using WoolClip and to be able to see firsthand how to create a WoolClip specification and incorporate eBale technology.

Workshops are structured to meet the level of all participants, from those with a high level of technology skills to first time users.

## **Mulesing Status Statistics**

Since last quarter a further 407,316 bales have received, and the national declaration rate has strengthened slightly to 74.5% (Table 4). As we start Quarter 3 of the 2023 selling season the bales offered at auction with a Non Mulesed mulesing status is 239,247 (Table 5), which sits 13.6%

higher than that reported over the corresponding period in season 2022.

Trends in declaration rate and mulesing status (Table 5) continue to remain consistent with reporting across the 2023 season.

## Season 2023/24 Highlights

As we approach Quarter 3, some of the 2023/24 SustainaWOOL season highlights include:

- Weekly catalogue compliance monitoring and auditing to ensure sale lots are correctly listed for buyers interested in sustainability.
- ii. SustainaWOOL auction lots accounted for 7.7% of all merino lots offered with lower passed-in rates as well as higher prices paid compared to equivalent fleece wool.
- iii. Completion of more than 40 on-farm inspections to underpin the integrity of the program.

- iv. Relaunched program strategy and execution phases for the program transition and relaunch
- Engagement and collaboration with key industry stakeholders to strengthen industry interoperability, and align metrics and standards for Australia's sustainable wool global market demands.
- vi. Establishment of the SustainaWOOL Expert Panel created to provide advice and oversight for the Standards, Performance Criteria and data/evidence requirements that underpin the Australian wool industries' on-farm sustainability assurance scheme.

#### **Auction Offerings**



Chart 1: Change in quantity of bales offered in Australian stores for the 2022 to 2023 seasons, broken into four-week intervals by Region.

#### Sale Weeks 1-39

Whilst the season to date totals are similar, the offering profile for Season 23 is unfolding in quite a different manner to Season 22.

Breaking this down into 4-week intervals (Chart 1), Season 23 opened with smaller offerings before gaining momentum in October to December with all regions recording increases for each interval, particularly in the North and South.

Offerings post-Christmas have been more subdued with Weeks 33-36 most notably falling 25% nationally over the same period last season.

Offerings in Weeks 37-39 have recovered to similar levels.

Looking at the offering in more detail, we can see the total offering for Weeks 1-39 are similar over the last three seasons, though in Season 23/24 the offering has been supplemented with more wool tested in previous Seasons.

#### **Data Parameters**

- i. Weeks 1-39
- ii. Excluding New Zealand, Includes Reoffers
- iii. For wool tested and offered in the Offer Season. (Wool tested in the Previous Season is not included). Typically for each of these

Seasons, 75% of wool tested and offered in Offer Season is offered within 11.9 calendar days. The length of time held in store for the remaining 25% is the factor that influences the total Average Time to Offer detailed above.
